Hi there, public comment below on the moratorium.

I'm not well enough versed in municipal governance to know whether the moratorium is the best way to do it, but since it's the process that's been started in order to slow and/or halt the development of Terawulf's Al data center, I'm behind it. I am completely opposed to the proliferation of artificial intelligence. To me, there is absolutely no way our society can meet the energy needs of both an electrifying transportation and home heating system AND artificial intelligence's takeover of the computing system and the web while also curbing global average temperature rise. Every fraction of a degree we can keep Earth from warming is good, and although we are clearly not stopping temperature rise fast enough to avoid climate disasters (rapid intensification of hurricanes and typhoons, larger and fiercer and more frequent wildfires like the ones in L.A. for example) we still need to transition away from fossil fuel use for transportation and heating. How can it be okay, given this context, for Terawulf to be using as much electricity as the ENTIRE COUNTY in their proposed facility? We have concerns about what Terawulf representatives claimed about the proposed AI data center in Lansing, NY.

Among many concerns raised during the first meeting was the question about the amount of noise the plant will produce. Terawulf representatives stated that it would be "about as loud as a dishwasher." A resident who lives close to the plant said that they did not want to hear a dishwasher when sitting outside enjoying the peacefulness of the lake. Furthermore, Terawulf's representative admitted that decibel levels the plant produces are measured only "at the property line." They are not responsible for any sound pollution beyond that. Yet the plant is on the water's edge. Water carries sound. Anyone who enjoys time on the lake knows that sound travels far beyond the property line. Furthermore, this potential sound pollution affects more than the Lansing community.

At the second meeting, Paul Prager attempted to define the company's board of directors as a wholly independent body of people whom he doesn't know personally. Meanwhile, Terawulf's top three officers, including Paul, serve on that board. It's not unusual for company officers to serve on a board of directors, but last night, he absolutely downplayed his own role as a board member. Prager stated the Cornell professor hired to do an "independent" study, was 100% independent. How is she independent when her study is funded by Terawulf? He said at the outset of that topic that they'd already paid her. Wouldn't a truly independent study be funded by a wholly separate, independent entity? Or even the town, maybe?

A data center's power usage fluctuates depending on the type and intensity of its workload, rather than a constant, peak-level draw. While servers must run constantly, higher user demand on more intensive computing tasks, like AI processing, cause significant spikes in electricity consumption. Does the burden of those spikes fall on the Lansing community? How do the Town and Planning Boards shield the local community from bearing the brunt of those additional costs? Does NYSEG get involved and guarantee that any overages are billed back to Terawulf and not the community? Like many CEOs, Paul Prager believes his company's presence is a blessing to Lansing, equating their arrival with winning the lotto, when history is literally littered with dozens of stories about big corporations harming local communities and leaving the residents with sometimes catastrophic environmental impacts. If history teaches us anything, companies like this are not so trustworthy. It's literally why we have, and need, government oversight, and legislation like the Clean Air and Water Act.

We are not saying Terawulf will do that, but he simply couldn't comprehend the fear Lansing folks voiced. "Trust me," was his main through line, and have the town and planning boards do their jobs. But as a community member pointed out, how equipped are the local town and planning boards, at this moment, when faced with the level of experience and professionalism and wealth of a Terawulf? It's questionable.

We think the well-intended hope is that a large billion-dollar company isn't going to fleece the community, and even more so, that it will actually provide the tax-base proposed. But could AI be a bit like Fracking, a boom and bust industry in which local residents really saw no financial benefit? At this point, AI is all the rage, it's the future, they claim. But we truly have no idea if this AI phenomena will last 10 years, 20 years, or even 30 years. It too could be a boom and bust strategy intended to make money for shareholders.

Prager even admitted that he is first and foremost accountable to the company's shareholders. Terawulf must be profitable... for the shareholders! Not the residents of Lansing. And not the employees working at the plant (as someone pointed out, the starting salary advertised to work there isn't even a living wage). Think about where we are in that pecking order when deciding Lansing's future.

All in all, Prager's arrival here, pitched as some sort of benevolent, community-first CEO, didn't really provide any more assurances than those offered during the first community meeting. In fact, Prager's commentary, especially his repeated lambasting of elected local officials, created an even deeper divide for many within the community.

We think all these observations about what the representatives said at the community meetings speaks to lack of transparency and potentially misrepresentations of the various impacts the AI data center will likely have on not only Lansing residents but all towns and communities on Cayuga Lake.

weekends and of taking advantage of Cayuga Lake has improved greatly. We now have two concerns about the proposed data center that incline us to favor the proposed one-year moratorium. One is, of course, that the disruption caused by the plant's construction and the increase of traffic on route 34B will cause the value of our property to fall and make it less desirable for our children and grandchildren to inherit. The other, which is broader and affects the whole town, is the prospect of a degraded natural and social environment in what is now a highly desirable residential area. We attended the meeting with the TeraWulf representatives at Lansing Middle School in October. We have several projects in development in New York, including a potential project in the Lansing area, which could offer many benefits to the citizens of Lansing including significant tax revenues, electric grid resiliency, and redevelopment of former industrial land. However, the pending moratorium on development being considered by the Town Board is concerning, and we hope the Board will allow us to work together to preserve their vision for the Town's future alongside the development of well-sited projects that benefit the citizens of Lansing. We note that in April 2023 the Town adopted ordinance changes that accommodate permitting for battery storage, specifically section 25T. This was after the adoption of the local comprehensive plan in 2018. It appears the Town has taken the necessary steps to ensure that battery storage projects are appropriate and comply with the vision outlined in the comprehensive plan. A moratorium on permitting battery storage projects is unnecessary as they already are approved and vested uses. The Town has included an exemption in Section 6 D for projects allowed under a Zoning Permit or Special Conditions (reference Town Code §§ 270-28 and 270-35), provided "no discretionary or environmental review is required." While we support this exemption, it is too restrictive; many valuable projects that align with the Town Board's vision may still need environmental review. Since the Planning Department, Planning Board, and Town Board have authority to assess such applications, the limitation excluding projects requiring review should be removed. We oppose the adoption of a blanket moratorium, but if the Town decides to move forward it should not eliminate the opportunity for permit applications for any activities that have Page 2 / 2 been incorporated in the Town's updated zoning code and are compatible with implementation of the Comprehensive Plan adopted in 2018. I've spent more than twenty years building and managing complex enterprise technology products, including leading "narrow AI" programs at one of the Big Four professional services firms. I also have worked with IT departments, Risk, and Compliance departments as well as Co-located datacenters in delivery of global webcasting, and the governance and security requirements for those facilities. I understand how today's AI works, what is needed from a governance perspective by derisking systems and providing guardrails but also why these systems require significant computing power, and how to judge whether a project is well-scoped, and managed.

I am not a specialist in plant retrofits, industrial water systems, or utility rate design. Those are complex fields that require licensed engineers and independent experts. Most residents and officials are not experts either, and their comments should be weighed through that lens. This is exactly why we need a simple, public process with neutral reviews and clear, easy-to-read reporting.

There is a real and growing need for data-center capacity to support AI; the project could benefit our region if it meets strong, verifiable standards for water, noise, air, energy, and community benefit. **We should not approve it on trust alone, and we should not reject it out of fear**. We should require proof.

My Recommendations

Independent review. From a Product management perspective, hire a qualified third-party firm, chosen by the Town, to review cooling design, water use, noise, energy, and traffic. Publish a plain-language summary for the public.

Simple, enforceable rules up front. Put clear conditions in the site approval:

- No water draw from Cayuga Lake and no discharge.
- No evaporation cooling now or later, unless specifically approved in a future public vote.
- Noise limits that must be met at the property line, day and night.
- Monthly public reporting: water in, water out (if any), hauled-waste volumes, and power use.

Meters and monitoring. Require utility-grade meters on all water coming in and any fluids going out, with third-party verification and a public dashboard.

Energy that matches what is used. Require a plan for clean energy that matches use hour by hour, not just yearly. Publish that data.

Community benefits with teeth. Local jobs, training, and a community fund tied to performance. If the company misses targets or breaks conditions, the Town can pause operations until it's fixed.

A Practical Middle Ground Worth Considering: A Limited Pilot with Safeguards

As a long-standing advocate for solutions that address the concerns and needs of all stakeholders, I believe there is a middle-ground approach. **Approve a small, time-boxed pilot with hard limits and automatic off-ramps:**

- Fixed size (for example, a single hall or small phase).
- No lake intake or discharge; no evaporation cooling.
- Full meters on water and energy; monthly public reports.
- Independent noise test after startup; publish results.
- A sunset clause: if any condition is missed, operations pause; if the pilot meets targets for 12 months, the Town may consider a modest scale-up with a new public hearing.

Key Questions (on the record)

- **Cooling:** Is the system fully closed-loop (no lake water in, no discharge out)? Provide a simple diagram with numbers for a hot summer day.
- Water: What is the maximum gallons per day needed under worst case? How is that verified?
- **Chemicals:** List the fluids and additives used, how much is stored, and exactly how used fluids are collected and disposed of.
- **Legacy intake:** When will the old lake-intake permit be formally surrendered? How is the structure physically disabled so it cannot be used?
- **Noise:** What is the noise level at the nearest homes, day and night, and how will it be tested after startup?
- **Power:** What is the total power need at full build out, and how will clean energy be matched hour by hour?
- Reporting: Will monthly reports be posted publicly in plain English with simple charts?

Risks (moving forward without strong conditions)

- Real water use and chemical risks could be hidden if there is no independent metering and no public reporting.
- Noise and heat from large cooling equipment could affect neighbors if limits aren't set and enforced.
- Power demand could raise pollution elsewhere on the grid if clean energy is not matched in real time.
- If the old intake/outfall and permits linger, they might be used later in a crunch.

Risks (not moving forward)

We could miss jobs, training, and tax base from a sector that is growing fast.

- All and high-performance computing will be built somewhere; turning it away without offering a safe, verifiable path means losing the chance to shape it responsibly here.
- Local researchers, incubators (such as REV Ithaca), startups, and schools may lose nearby capacity and industry partnerships.

Important Note About Cloud Providers and Business Risks

Third-party data centers ride on the "rails" owned by Amazon (AWS), Microsoft (Azure), and Google Cloud. Like the railroad trusts of the robber-baron era, these platforms control the tracks, prices, and terms. If they raise rates or change rules, a data center's costs can spike with few real alternatives. To keep those shocks from rolling downhill to residents, the Town should require TeraWulf to show how it will stay viable under price hikes and to maintain financial backstops.

Closing

This project could be a win for the community, startups, and people working in AI. Subject-matter experts should judge the technical intricacies of the project and report back to elected officials but only if it is measured, monitored, and managed in the open. Give the public clear facts, not guesses. Set firm rules now, verify, and publish the results. That's how we protect Cayuga Lake, respect neighbors, and still welcome good jobs and innovation.

To concerned parties of the Town of Lansing,

I write today to support the moratorium proposed for new developments in the town. My support comes from a place of concern for the TeraWulf data center development that will take place without the moratorium's implementation. I am an environmental studies major who lives in central NY, so I have both an intellectual concern and a concern for my larger community. AI data centers have horrible effects on local ecosystems, local electrical grids, and have immense carbon emissions. Please enact this moratorium to allow for more time to review regulations and environmental impacts: this data center will hurt Lansing more than stalling development. Breaking down this issue, there are localized and general effects of an AI data center such as TeraWulf's planned development. TeraWulf insists that they will not affect the local environment, using a closed system for cooling and bringing in outside water sources to solve this issue. This however is a departure from similar data centers run by TeraWulf, like the center in Barker, which use hybrid systems that draw from the closest body of water. This model releases warm water that can be contaminated back into the surrounding ecosystem, creating ripple effects of damage to local wildlife and natural resources. In this model, water would also be drawn from the lake itself: This action in itself is harmful to the lake ecosystem. The real question is why would TeraWulf build this data center in a coal power plant that has a lake intake and assure they would not use the lake water? Would it not make more sense to develop away from the lake if there is no use for it? The localized impacts are not limited to the environment. Electricity prices can be expected to increase with the introduction of data centers for local residents. The increased demand that the data centers will put on the grid will inevitably raise rates for living near the center.

Beyond local effects, data centers have immense carbon emissions due to their high energy usage. Even though the grid is cleaner in Lansing than many other places in the country, the high demand for electricity still carries a weight of carbon based electricity.

Looking at the tradeoffs makes this a clear-cut case: what does Lansing stand to gain from this? There will be an opportunity for new jobs. What does Lansing stand to lose? You will lose the natural resources and ecosystems Cayuga Lake has to offer, the low electricity rates you possess, and the conscience knowing you aren't contributing so directly to the climate crisis.

The answer is clear: continue with the moratorium and push back on TeraWulf's project with renewed zoning that protects your residents and environment.

Town of Lansing Supervisor, Town Board and Town Clerk:

The New York Public Interest Research Group (NYPIRG) submits these comments and urges the Town of Lansing (the "Town") to adopt the above-referenced moratorium to place on hold the TeraWulf Data Center development proposal to allow time to assess the potential and likely harms that could impact the Town and greater Finger Lake Region of the project. This is a momentous decision, with the well-being of the community's access to clean air and affordable energy hanging in the balance.

TeraWulf seeks access to 400 MW of electricity that could otherwise be distributed to residential customers to light and heat their homes, fuel their automobiles and power local small businesses. In its statement, TeraWulf claims they access electricity at \$.05 per kilowatt-hour. NYSEG residential customers continue to pay over \$.07 per kilowatt-hour. According to NYSEG, 500,000 homes could be powered by 400 MW.

There is a risk that this increased electricity demand will lead to energy shortages and higher energy costs – particularly during high-demand days. Advocates and lawmakers statewide are citing high utility costs – of particular concern as upstate temperatures turn sharply colder in late fall. Siphoning off energy from the shared grid will result in higher energy costs for New Yorkers who are already paying too much and struggling to keep their lights and heat on.

In addition, the potential for devastating the Town and the local Finger Lakes community, energy-hogging activities like data centers used in industrial Artificial Intelligence (AI) production imperil New York's ambitious climate mandates. Environmental Conservation Law Article 75, the Climate Leadership and Community Protection Act, became effective January 1, 2020. It requires that New York steadily increase

the amount of renewable sources for its energy and reduce greenhouse gas (GHG) emissions from all human-generated sources within the state. Statewide GHG emissions must be reduced 40% below 1990 emissions by 2030, and 85% 1990 levels by 2050.

In conclusion, NYPIRG supports the Town of Lansing's proposed moratorium so that residents and businesses are given more time to learn about the impacts that TeraWulf may impose on the local community, the region, small businesses, residential ratepayers, and the state's climate goals.

They voted down the original proposed moratorium, as they did not believe it was necessary, and Colliers echoed this sentiment. Additionally, two town board members have publicly stated their opposition to the moratorium.

Moving forward with this moratorium suggests that there may be a personal agenda at play, rather than an initiative genuinely aimed at benefiting our community. The recent election clearly demonstrated that the majority of our community is against the moratorium and supports the standard practices that are already in place.

If the intent of the moratorium is related to A.I. concerns, I urge you to disregard outside noise and focus on the voices of those who live here and genuinely care about our town.

Much of the external criticism surrounding the moratorium is founded on misinformation. Claims that it will harm the lake are unfounded; we all know that the DEC would never allow such damage to occur, nor would the residents of our town stand for it. While it is true that certain processes consume water, we must remember that water is our most abundant natural resource.

Now is the time to establish clear standards for TeraWulf to abide by. The process has already been lengthy, and implementing a Project Development Agreement (PDA) will only extend it further.

It's crucial that we communicate our expectations as community members. We need to make it clear what WE want. If TeraWulf is unwilling to meet these standards, we must be prepared to tell them they are not welcome in our community.

Let's stand united in ensuring that our voices are heard and that any developments align with the interests of our community.

I implore you to trust the residents of Lansing and to listen to our concerns. Please do not approve the moratorium.

Thank you for considering my perspective.

Rather than receiving letters solely for or against the moratorium, I believe it would be more productive to solicit ideas from community members about what they would like to see if the A.I. initiative was to move forward.

Encouraging constructive feedback and innovative suggestions will help us shape a development that aligns with the values and needs of our community. Let's focus on collaboration and creativity rather than division.

My name is Vanessa Wood. I am a longtime resident of Dryden, and my drinking water comes from Cayuga Lake. I have lived in this area for 21 years, and work in STEM. I am commenting on Local Law #7 for a temporary moratorium for certain developmental actions. I am in favor of a moratorium for the proposed development of an AI center in Cayuga Lake. There is reason to be concerned with this development on local wildlife, human and pet health, and local energy bills. We have the benefit of being able to assess the impact of existing AI data centers on other communities. These centers always use large amounts of energy that should be concerning to residents, especially as they impact the environment, energy grid, and energy prices of residents long term. Also, they use large amounts of water, which may heat and otherwise pollute source water for drinking and recreation in communities. Considering that Cayuga Lake has recently shown signs of being at a tipping point for harmful algal blooms, even a small increase in sustained temperature would likely cause negative ripple effects in the bio activity of the lake.

While the SPEDES permit for the location for the proposed development may not be associated with the proposed project, questions remain about why it was filed when it was, and time should be given to further scrutinize and understand this effort. While I don't currently have enough information to assess all of the factors personally, my knowledge of watershed impacts does raise concerns about the high discharge temperature on this permit, and the impact that may have on harmful algae. Harmful algae is dangerous to humans and other animal life.

In regards to the conduct of representatives of this project so far, it is very concerning. The tone of these conversations, especially at the last meeting, has already dipped into condescending, belittling, dismissive, and borderline abusive attitudes towards residents. I have no reason to believe that the industry decision makers have our best interests in mind, are acting in good faith, or are being honest.

Many aspects raise suspicion of possible harm and deception, from the SPEDES permit which does not make sense, the fact that this center is right on the lake yet they expect us to believe that is a coincidence and they don't plan to discharge water despite other AI centers huge use of water, and the outrageous assertion that some of the onus is on residents to build trust with outside

corporations looking to exploit and use our natural and energy resources, not to mention the typical history of AI centers dismissive and exploitative relationship with communities. Even if water is not discharged, that means massively more energy used.

Whatever financial short term gain for a small number of people locally, and the long term gain of financial and other goals of huge corporations may result from such a project is not worth the almost certain harmful and exploitative impact on our beautiful community and environment. Please keep your wits about you.

Dear Lansing Town Officials, I am writing as a college student from Upstate New York who is concerned about protecting the earth, culture, and economy in the region. I support Local Law #7 of 2025, which would put a temporary moratorium on the zoning and proposed construction of the TeraWulf data campus on Cayuga Lake. We need more time to fully consider the environmental and social implications of the presence of this tech conglomerate on Cayuga Lake and create an alternative course of action. Intrinsic value of the region: It is difficult to ignore the sheer natural beauty, distinct seasons, ecological diversity, and flourishing towns across the state of New York. This is particularly apparent in the Finger Lake region: I visited a friend at Cornell University over the summer, and I recall the joy of eating dumplings from an Ithaca Farmer's Market vendor while sitting on the dock on Cayuga Lake. Imagine if, instead of uninterrupted riverbanks and cultural richness, there was a massive data center across the water and the roar of computers in the air? Supporting this moratorium is a way to protect my state's biodiversity and communities from industrial threats, and I am keenly aware of how unfortunate it would be to lose everything in favor of an AI data center destined to pollute and destroy. Failure to give back to the community: I believe it is wrong to introduce an industry that not only uses, but jeopardizes natural resources, such as land and water, without giving back to the community. TeraWulf's data center will replace the defunct coal-fired Milliken Station Power Plant, but instead of generating power for public consumption, all the power will be used to fuel the mega-computers, most likely increasing electricity bills for locals without actually improving their electricity access. Additionally, this project will affect the lake ecosystem. Cooling the computing equipment requires vast quantities of cool water to be pumped into the computer storage areas, after which the spent water will enter the ecosystem once more. Higher water temperatures and pollutants kill aquatic life and increase vulnerability to algal blooms. Measures must be put in place that will prevent the water temperatures from rising too much, but even if TeraWulf can put a system in place that will not use water from Cayuga Lake, as they claim is already being done, there are other serious ecological repercussions to building a data center in Lansing. When we consider the negative externalities, such as noise pollution, water pollution, higher water temperatures, and higher bills, all of which will be felt by residents of Lansing, it is clear that TeraWulf's construction plan is ill-advised. Effects on communities and environment: Even if no water from Cayuga Lake is used and no financial burdens are placed upon the town of Cayuga, TeraWulf should not consider moving forward with this project. A moratorium should be placed immediately, regardless of whether the plans to build the data center are backed by lies or good intentions. There is inherent value in having a lake and town that are undisturbed by industry, particularly an industry experiencing an economic bubble effect. It is not a long term project, because if the data center fails, then TeraWulf will move onto cryptomining as they have done in the town of Somerset, NY. At the end of the day, they have no right to invade, bringing ecological and social disruption to the town of Cayuga, which is a place people call home.
